Directions hearing.

- Black J grants leave to Bluebay US\$ Global Convertible Bond Fund (Canada) and others together described as the committee of bondholders, to appear under r 2.13 of the Supreme Court (Corporations) Rules.

Black J makes the following directions:

1. Stand the matter over for further directions before Black J at 9.15am to 2 January 2018.
2. Note that the Plaintiffs seek to have the matter listed for hearing on 16 January 2018.
3. Direct the Plaintiffs to give notice to shareholders in Paladin Energy Limited (Subject to Deed of Company Arrangement) of the next directions hearing in this matter, provided that such notice may be given by publication on a website that is used for communications with shareholders in the ordinary course.
4. Liberty to restore before the Duty Judge or, from 1 January 2018, before Black J, on one business days' notice, with such notice to be given to Electricité de France if that restoration relates to matters as to confidentiality.
