## Update on Transaction with Fission Uranium

---

Paladin Energy Ltd (ASX:PDN OTCQX:PALAF) ("**Paladin**") provides an update regarding the proposed acquisition of Fission Uranium Corp. (TSX:FCU OTCQX:FCUUF FSE:2FU) ("**Fission**") by way of a court-approved plan of arrangement under the *Canada Business Corporation Act* ("**Arrangement**").

Completion of the Arrangement remains subject to closing conditions, including receipt of a final order approving the Arrangement (the "**Final Order**") from the Supreme Court of British Columbia (the "**Court**") and *Investment Canada Act* clearance.

The hearing before the Court for the Final Order concluded on 26 September 2024 (the "**Final Hearing**"). CGN Mining Company Limited ("**CGN**"), a subsidiary of China General Nuclear Power Corp. that, to the knowledge of Paladin, holds a disclosed interest of 11.26% of the outstanding common shares of Fission, opposed the approval of the Arrangement at the Final Hearing. The Court is expected to deliver its decision in the coming weeks.

On 2 October 2024, Paladin received a notice from the Minister of Innovation, Science and Industry ("**Minister**") ordering a national security review of the Arrangement under section 25.3 of the *Investment Canada Act* ("**ICA**"). Accordingly, consideration of the Arrangement under the ICA has been extended and remains ongoing. Paladin is considering the Minister's notice, exploring its available options and evaluating the prospects of obtaining ICA clearance in respect of the Arrangement.

There can be no certainty that the Court will grant the Final Order, or that ICA clearance will be forthcoming, or that the Arrangement will be successfully completed.

Paladin will continue to keep the market informed of all material developments.
